

How it Works

To use NotaryCam, have a PDF or Word file of the form, a valid government issued color ID, steady internet connection, and a device with a webcam and audio to meet with the notary online.

- Upload the document
- Connect to a live Notary and confirm your identity face-to-face on a webcam.
- Document is electronically signed and an eNotary seal is applied.
- Document is immediately available for download.
